Petition for Referendum is Invalid Again

GlendaleFirst! has completed its in-depth investigation of Petition for Referendum R-12-02 and concludes that while the required 6956 signatures are not due until December 27, 2012, all signatures collected thus far are invalid. The petition paper work the political committee "Back To Sanity", chaired by Francine Romesburg with Ken Jones as Treasurer have filed with the City of Glendale is fraught with fatal flaws.

Petitioning for a Referendum against a municipal action in Arizona requires following a few procedures. On page ONE of the handbook handed to everybody "pulling a packet" for a petition (which was done on November 29, 2012 in this case) is the following sentence:

*"An application for a referendum petition serial number along with a 100 word description and a copy of the measure must be filed with the *Secretary of State*^{*} before the circulation of the petition." (^{*} *for local elections Secretary of State should be replaced with City Clerk, and will be replaced as such in the remainder of this release*)*

The above sentence indicates that, when submitting an application, the person applying must submit to the clerk a 100 word description of the petition and a copy of the actual measure to be referred as a ballot measure. Jones and Romesburg, in this case ONLY filed the application itself, leaving out both the 100 word description and the copy of the measure.

The 100 word description must also be printed on the face of the petition in no less than 8 point type for later comparison with the filed description when verifying turned in petition sheets. This description must be on file with the clerk's office BEFORE any petitions are circulated.

Back to Sanity also failed to file the actual text of their measure. This text must be on file with the city before the petitions are circulated. This text is the actual text that the citizens of Glendale would read and vote upon. This measure must also be printed on each petition sheet used to gather signatures. Again, this must be on file BEFORE any petitions are circulated.

Either of these errors would be cause to reject the entire petition on its own, Back To Sanity's petition serial number R-12-02 has TWO of these severe errors.

We at Glendale First! find these to be egregious errors, in light of the fact that EXACTLY five months to the day (July 12, 2012) we wrote a press release nearly identical to this for Referendum R-12-01, when Mr. Jones and his former partner Mr. Joe Cobb, attempted to gather signatures on a similar referendum. Mr. Jones received a letter from the City of Glendale detailing the errors in his last petition attempt, which he then duplicated in the current referendum effort.

Glendale First! is under the impression that the City of Glendale has sent a letter to Back To Sanity notifying them of the errors in their filing. We are not sure why the City felt compelled to notify the committee before the petition sheets had been filed with the Clerk's office considering that this was not the procedure followed in July 2012 for R-12-01. We assume clarification will be forthcoming in the next several days.

Glendale First! therefore concludes that, because of the above technical errors in the documentation and registration of Petition for Referendum R-12-02, all signatures in support of the petition for referendum would be rejected outright upon discovery of the above two major flaws. Arizona courts have opined that referendums require strict compliance to the laws, where initiatives only require substantial compliance. So, regardless of any possible dispute of the number of days available to collect signatures, that point is moot because the signatures were being collected in support of an invalid petition.

GlendaleFirst! has an army of dedicated volunteers working on education and signature suppression over the past 6 months, we have asked our people to cease operations as of today, and enjoy the holiday season with their friends and family. It has truly been a privilege to engage the community alongside so many passionate and dedicated men and women.
